

REGISTRATION/MEMBERSHIP COSTS

To those having a membership with or desiring a membership with WVAPPA: At this point in time attendance at the Spring Conference is one in the same with membership. Costs and titles for those employed at a WV Higher Education Institution are as follows:

REGULAR MEMBER

Facilities Professional working at a WV Higher Education Facility employed directly by the school \$25 for Jan 1, 2009 through December 31, 2009

AFFILIATE MEMBER

Facilities Professional working at a WV Higher Education Facility employed by a for-profit-entity dedicated to facilities work \$25 for Jan 1, 2009 through December 31, 2009

HONORARY MEMBER

Attained by special action of the WVAPPA Board of Directors. No membership costs associated with this class.

EMERITUS MEMBER

Retiree of Higher Education Institution with meritorious service to WVAPPA. Attained by special action of the WVAPPA Board of Directors. No membership costs associated with this class.

COSTS WITH THE ABOVE MEMBERSHIP WILL GRANT ACCESS TO THE SPRING CONFERENCE.

ALSO NOTE THAT THE COSTS WILL GRANT THE MEMBERS ATTENDANCE AT THE

BANQUET. GUESTS OF THE MEMBER MUST PAY AN ADDITIONAL \$30 PER PERSON FOR THE CONFERENCE AND BANQUET ATTENDANCE.
